#### **VESPA REPORT**

Mr. Ruben Galindo, VESPA President, reported:

- 1) VESPA and VUEA are working with Buena High School to have a 7<sup>th</sup> period day on campus so they can be competitive with Ventura High School. So far, both unions are for it and it passed the first round of voting. It was also approved by the School Site Council. The next step is a review by the District Steering Committee. If it passes, it will then go on to a second round 2/3 vote by both unions.
- 2) VESPA also started negotiations with the District. We recently negotiated a week ago and our next session will be December 4<sup>th</sup> for contract language.

#### ITEM F2

#### **DIRECTOR'S REPORT**

Ms. Crouch reported:

- 1) The district started negotiations with VESPA. In addition to the full negotiations team, a salary subcommittee will meet to review budget, identify comparable districts and explore creative options regarding total compensation. This committee meets on Monday.
- 2) There have been some changes amongst the District leadership team. Gina Wolowicz was recently promoted to the Director of Curriculum & Instruction, Elementary; she was Principal at Juanamaria Elementary. She started her new position on October 1<sup>st</sup>. On Tuesday night, the Board approved appointing Mike Askay, current Assistant Principal at Anacapa, to the Principal position at Juanamaria. His start date is still to be determined.
- 3) We will have two new Board members joining the Board of Education in December. Jerry Dannenberg was recently elected; he will be filling John Walker's seat. Matt Almaraz will also be joining the Board and was elected from Trustee Area 5.
