### **VESPA REPORT**

Mr. Ruben Galindo, Vice President, of the Ventura Education Support Professionals Association (VESPA), gave an update on some activities of the Association since the last Personnel Commission meeting. He reported that VESPA has 2 grievances in motion in Transportation and they are working closely with Wendy Stevens, Director of Transportation to resolve them. One is for Article 13, field trip hours are not being posted in a timely fashion and the other one is under the transportation policy and procedures, 3.5, the assignment of extra hours.

### ITEM F2

### **DIRECTOR'S REPORT**

Ms. Crouch informed the Commission of the following:

- 1) Some changes have occurred in administrative positions here at Ventura Unified.
  - Carlos Covarrubias was appointed as the Principal of Balboa Middle School
  - Mayra Vega was appointed as Interim Principal at EP Foster Elementary
  - We are also starting to receive many retirements from Administrators, staff and some classified employees. As you may already be aware, Joseph Richards, our Deputy Superintendent of Business Services announced his retirement, and will be retiring as of June 30<sup>th</sup>. We will deeply miss Joe, not only as a special person and co-worker, but as a very wise and thoughtful leader. The position will revert back to an Assistant Superintendent of Business Services, and the recruitment is currently open. The deadline to apply is April 16<sup>th</sup>. Our Directors of Special Education have also announced their retirement, so some restructuring of that department is underway and recruitment efforts are currently open for an Executive Director and Assistant Director.

- 2) Summer School recruitment closed on March 16<sup>th</sup>. We received approximately 120 applications. Classified HR will start working on assignments and notifying employees when we return from spring break.
- 3) Preparations are starting for the development of the 2018/19 PC budget, which will be presented for a first review at our PC meeting next month.
- 4) We're gearing up for possible layoffs. We expect anticipated reductions/eliminations to go to the Board for approval during April and possibly into May if needed. Our office will then start working with VESPA to go through the layoff process and bumping rights of affected employees.

Ms. Crouch continued with the following VUSD calendar highlights and upcoming events: the next regular Board meeting is scheduled for Tuesday, March 27; Board Holiday – District Closed – Friday, March 30; Spring Break – No School – April 2 – 6.

Proposed revisions to PCRR 150.8, Personal Necessity Leave were discussed. Ms. Crouch shared that the district recently re-negotiated contract language regarding PNL and the revisions would reflect the same changes as negotiated with VESPA. On a motion by Ms. Rice, seconded by Mr. Kirby, and supported by the Chair, the Personnel Commission approved setting final review and action to approve the revisions to PCRR 150.8 at its next scheduled Commission meeting by a vote of 3-0. # ITEM G4 APPROVAL OF NEW CLASSIFICATION AND SALARY ALLOCATION: NETWORK AND SYSTEMS SPECIALIST
