Consideration for Adoption of Digital-only McGraw Hill "Inspire" Science Curriculum for Grades 6-8

July 7, 2020



The consensus recommendation for adoption from the pilot committee was "Inspire" by McGraw Hill for grades 6-8.

This recommendation was presented to the board by Bret Klopfenstein and Greg Bayless prior to the Covid-19 school closures.



- Given the 1:1 computer-student initiative underway and preparations for the likely hybrid distance-learning/classroom learning environment in the fall of the 2020-21 school year, the recommendation is to purchase year-by-year access to the "Inspire" digital materials.
- Given the initiative to build secondary courses in Canvas in preparation for hybrid learning, a Next Generation Science Standards-aligned digital curriculum is recommended for builders to use in building Canvas courses in summer 2020.
- The cost of yearly access to grades 6-8 materials is: \$69,000
