# **PUBLIC COMMENTS**

Public comments are welcomed and encouraged by the Board. A member of the public who would like to address the Board they will be encouraged to fill out a "Speaker Card" prior to the item being called, on the evening of the meeting. No additional speaker cards will be accepted after the item being called, on the evening of the meeting. As stated in Board Bylaw 9323, a person wishing to be heard by the Board shall first be recognized by the president and shall then proceed to comment as briefly as the subject permits. Individual speakers shall be allowed three minutes on any agenda item with a cumulative total of five minutes for all agenda items. The Board shall limit the total time for public input on each item to 20 minutes. With Board consent, the president may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The president may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add. Also, speakers will not be allowed to give their time to other speakers. The Board is prohibited from taking action on any item that is not part of the published agenda.

Because the Governing Board has a responsibility to represent the public's interest in negotiations with employee organizations, the Board is committed to keeping the public informed about issues being negotiated, providing members of the public an opportunity to express their views, and disclosing the position of each Board member.

New subjects of meeting and negotiating arising after the presentation of initial proposals shall be made public within 24 hours. If a vote is taken on any such subject by the Board, each member's vote also shall be made public within 24 hours. (Government Code 3547)

# **Public Disclosure**

Before entering into a written agreement covering matters within the scope of representation, the Board shall disclose, at a public meeting, the major provisions of the agreement, including but not limited to the costs that would be incurred by the district under the agreement for the current and subsequent fiscal years. (Government Code 3547.5)

A copy of the proposed agreement shall be made available to the public prior to the day of the Board meeting.

The Superintendent or designee shall prepare a summary of the major provisions and changes in the proposed agreement.

# Certification of Agreement

Before the Board approves any agreement, the Superintendent and chief business official shall certify in writing that any costs incurred by the district under the agreement can be met by the district during the term of the agreement. The certification shall itemize any budget revision necessary to meet the costs of the agreement in each year of its term. (Government Code 3547.5)

# **Background Information**

California Education Code Section 45246 provides that, "Where a [merit] system is already in existence and a vacancy in the position nominated by the classified employees will occur, the classified employees shall submit the name of its nominee to the governing board at least thirty days prior to the date on which the vacancy will occur and the governing board shall appoint that nominee to be effective on the date on which the vacancy will occur."

The term of the Ventura Educational Professionals Association's appointee to the Personnel Commission expires at noon on December 1, 2019. Mr. Ruben Galindo, President of VESPA, has submitted nominee, Ms. Cathi Stallings, as VESPA's intended appointee to the Personnel Commission for a three year term, commencing at noon on December 1, 2019.

#### Recommendation

Therefore, it is recommended that the Board of Education approve Ms. Cathi Stallings as VESPA's appointee to the Personnel Commission, effective at noon on December 1, 2019.

# **Business and Noninstructional Operations**

Transportation may be furnished at district expense for specified activities.

Transportation may be furnished at student or student body expense for specified activities.

The cost of bus transportation will be determined annually on the basis of operating costs for the previous year and will be limited to the actual operating costs.

Special student activity buses leased from private businesses must follow all rules and regulations in regards to insurance, safety, liability and driver qualification.

Trips by School Vehicles

Besides taking students to and from school, school vehicles shall provide transportation for field trips and for special activities approved by the Superintendent or designee. Such trips may be taken in buses or other school transportation vehicles owned, leased, or rented by the district. All vehicles shall meet federal and state standards.

The Superintendent or designee shall maintain procedures to regulate the use of the vehicles for approved school-related activities. Activity trips occurring outside of school hours shall be subject to the rules and policies regulating educational field trips. Student councils, parent-teacher associations, and any other organizations requesting transportation shall be fully responsible for the costs of the trip. To the extent that funding has been approved by the Board, such costs may be charged to the district.

# Transportation by Private Automobile

Transportation by private automobile is not recommended and can only be granted with the consent of the Superintendent or designee. Field trip/Transportation Request form must be submitted to the Superintendent or designee no less than three weeks prior to the planned trip. Each driver is to complete a "School Driver Certification Form". Each driver must be at least 21 years of age and have a valid California Drivers' License and maintain liability insurance of at least \$300,000 per occurrence and have a current vehicle registration. All student passengers shall have on file at the site the Parent Acknowledgement of the Use of Private Transportation form signed by their parents/guardians which acknowledges the use of a private automobile (and indicates the name of the driver). Parent permission slips (Field trip or Excursion Authorization and Medical Treatment Authorization form) are required for each trip.

If authorized, when parents choose to drive only their own children to/from field trips, athletic competitions, band trips, or other school-related activities, they are to complete a school sign out form, a personal vehicle use form or a school activity transportation signout sheet, in addition to the parent permission slip (Field Trip or Excursion Authorization and Medical Treatment Authorization Form).

Students are required to travel on buses, vans or other transportation provided by the District to and from all school-sponsored activities, practices, games and events. However, under certain circumstances, parents may request that students drive themselves. If authorized, a VUSD Student Transportation Permission Form and a Personal Vehicle Use Form must be completed. This is in addition to the parent permission slip (Field Trip or Excursion Authorization and Medical Treatment Authorization form).

Owners, drivers and passengers shall be informed that the registered owner and his/her insurance company are responsible for any accidents which may occur.

A seat belt must be provided for each passenger.

The number of passengers, including the driver, shall not exceed the capacity for which the vehicle was designed and should not in any case exceed 10 passengers. If trucks are used, all passengers must only ride in the cab. (Education Code 38045)

Owners furnishing private vehicles shall not accept reimbursement from passengers in excess of the cost of operating the vehicle.

Whereas, textbooks or instructional materials in core curriculum subjects should be aligned with state academic content standards adopted by the State Board of Education pursuant to Education Code 60605 and/or the Common Core Standards adopted pursuant to Education Code 60605.8;

Whereas, sufficient standards-aligned textbooks or instructional materials that are consistent with the cycles and content of the curriculum frameworks is provided to each student, including each English learner, in the following subjects; mathematics, science, history-social science, and English/language arts, including the English language development component of an adopted program, and foreign language and health, and;

Whereas, laboratory science equipment is available for science laboratory classes offered in grades 9-12, inclusive;

Therefore, it is resolved that for the 2019-20 school year, the Ventura Unified School District, has provided each student with sufficient standards-aligned textbooks or instructional materials that are consistent with the cycles and content of the curriculum frameworks.

The Governing Board recognizes that involvement in civic and political institutions is essential to a democratic government and desires to provide a comprehensive civic education program to help students acquire the knowledge, skills, and principles essential for informed, engaged, and responsible citizenship.

The Board shall approve, upon the recommendation of the Superintendent or designee, academic standards and curriculum in civics and government that are aligned with state academic standards and curriculum frameworks.

The Superintendent or designee shall determine specific courses within the K-12 curriculum in which civic education and government may be explicitly and systematically taught. He/she shall also encourage the integration of civic education into other subjects as appropriate.

The district's civic education program shall provide students with an understanding of the rights and responsibilities of citizens in American democracy and the workings of federal, state, and local governments. As appropriate, instruction should include an examination of fundamental American documents, including, but not limited to, the Declaration of Independence, the United States Constitution, the Federalist Papers, and other significant writings and speeches. Instruction should also promote a student's understanding of shared democratic principles and values, such as personal responsibility, justice, equality, respect for others, civic-mindedness, and patriotism, and enable students to make their own commitment to these civic values.

Service learning, extracurricular and cocurricular activities, class and school elections, simulations of government, student-led debates, voter education, and observation of local government processes may be used to reinforce classroom instruction by linking civic knowledge to practical experience and encouraging civic involvement.

Each year on or near September 17, in commemoration of Constitution and Citizenship Day, the district shall hold an educational program for students in grades K-12 pertaining to the United States Constitution which shall include exercises and instruction in the purpose, meaning, and importance of the Constitution, including the Bill of Rights. (Education Code 37221; 36 USC 106 Note)

**Student Voter Registration** 

To encourage students to participate in the elections process when they are of voting age, the Superintendent or designee shall provide high school students with voter registration information, including information regarding the state's online voter registration system.

The Superintendent or designee shall identify an employee at each high school whom the California Secretary of State may contact to facilitate the distribution of voter registration forms to eligible students. The Superintendent or designee shall provide the business address, phone number, and email address of each contact person to the Secretary of State. (Elections Code 2148)

The designated employee shall determine the most effective means of distributing voter registration forms provided by the Secretary of State, which may include, but are not limited to, distributing the forms at the start of the school year with orientation materials, placing voter registration forms at central locations, including voter registration forms with graduation materials, and/or providing links and the web site address of the Secretary of State's online voter registration system on the district's web site and in email notices sent to students.

The principal or designee may appoint one or more students enrolled at each high school to serve as voter outreach coordinators at that school. The voter outreach coordinator(s) may coordinate voter registration activities at the school to encourage eligible persons to register to vote. With the approval of the principal or designee, the voter outreach coordinator(s) may also coordinate election-related activities on campus, including voter registration drives, mock elections, debates, and other election-related student outreach activities. (Education Code 49041)

During the last two full weeks in April and September, in areas on each high school campus that are reasonably accessible to all students as designated by the principal or designee, the county

elections official shall be allowed to register students and school personnel to vote. (Education Code 49040)

At least once yearly, in-class, teacher-led instruction regarding voter registration will be provided to high school students in grade 12 in all required-for-graduation Government/American Democracy/AP Government courses.

While every effort will be made to have these voter registration lessons occur during one of the two designated State of California High School Voter Education Weeks in September and April, a teacher may make prior arrangements with the site principal to schedule the lessons at a different time of year due to extenuating circumstances.

During all in-class and on-campus voter registration lessons and activities, the following shall apply:

- 1. There is no requirement that teachers must allow groups/guest-speakers into the classrooms or onto campus for these lessons and/or activities.
- 2. Students shall not be coerced into registering to vote. For Grade 12 students who choose not to register, an alternative assignment shall be offered during the in-class lessons in a way that does not bring any negative attention to the student.

3. Whenever civic education includes topics that may be controversial due to political beliefs or other influences, instruction shall be presented in a balanced manner that does not promote any particular viewpoint. Students shall not be discriminated against for expressing their ideas and opinions and shall be encouraged to respect different points of view.

- a. - b. VUSD Board Policy and Administrative Regulation 6141.2, 6141.6 and 6144 regarding recognition of religious beliefs and customs, multicultural education and instruction on controversial issues shall be upheld.
- 4. Whenever possible during the in-class lessons, teachers will instruct students in the online voter registration portal rather than the paper/pencil voter registration application.

# Student Voter Registration

The Governing Board recognizes that community engagement and civic participation are important parts of a student's education. The Board also regards the right to vote as one of the most important rights of citizenship in a democratic country. The Board holds as a high priority the important role of all staff members in informing students of the importance of registering to vote and assisting students in this process. The Governing Board acknowledges the California Secretary of State's encouragement for school districts to participate in voter registration activities.

It is the intent of the Legislature that every eligible high school and college student receive a meaningful opportunity to apply to register to vote. It is also the intent of the Legislature that every school does all in its power to ensure that students are provided the opportunity and means to apply to register to vote (California Elections Code 2146).

# **Legal Foundations**

California state law allows 16 and 17 year olds to pre register to vote with their voter registration coming into effect as soon as they turn 18.

Assembly Bill 1817 (Statutes of 2014) designates the last two full weeks in April and September as High School Voter Education Weeks and encourages school districts to conduct voter registration and education drives on campuses and in classrooms during these four weeks.

California Elections Code 2146 requires the Secretary of State to annually provide high schools-with enough voter registration forms for all students who are of voting age or will be of voting age by the end of the year. As added by SB 854 (Ch. 481, Statutes of 2007), Elections Code 2148 requires every high school to designate a contact person and provide his/her address, telephone-number, and email address to the Secretary of State to facilitate the distribution of voter-registration materials.

Student Voter Registration
The following procedures are to be used in order to implement the intent of Board Policy 5134:
A. To encourage students to participate in the elections process when they are eligible, the Superintendent or designee shall determine the most effective means of distributing voter registration forms provided by the Secretary of State.
B. Under the direction of the Superintendent or designee, each high school will designate a staff contact person and provide his/her address, telephone number, and email address to the Secretary of State to facilitate the distribution of voter registration materials.
C. Annually, during the High School Voter Registration Weeks (the last two full weeks of September and April), each high school will provide adequate time within its social science courses for teachers to assist age appropriate students in the process of voter registration, which may be accomplished either on a paper form or online.
D. Teachers shall provide a context for the voter registration activity as well as opportunity for age-appropriate students to register to vote. The Board believes that students who are given information on why voting is important and how to register are much more likely to register to vote than those who are simply handed a form.
E. Teachers will encourage students to use the classroom opportunity to register to vote but will not advise, counsel, or suggest to students in any way how to vote on any particular ballotissue.
F. Students' participation in the voter registration will be entirely voluntary on their part. No part of the students' course grades will be dependent upon their participation or lack of participation in the voter registration process.
G. Instructors will announce during the days prior to the in-class voter registration process that students should come to class prepared with the last four digits of their social security number or with a California ID or driver's license, at least one of which they will need to complete the voter registration form, if they intend to participate in the voter registration process

H. Students will not be required to provide postage, mail or turn in voter registration forms on their own. Students will be given the opportunity to turn in completed voter registration forms

to their instructors. At the end of Voter Education Weeks, all forms will be collected by each school and returned to the County Registrar by a procedure determined by the Superintendent or designee and in compliance with California law and the Elections Code.
I. District staff may also invite nonpartisan community organizations to provide voter- registration information and services to students on campus outside of students' social science courses.
J School principals, or their designees, may appoint one or more pupils who are enrolled at that high school to be a voter outreach coordinator. A voter outreach coordinator may coordinate voter registration activities on his or her high school campus that encourage age appropriate students to vote. A voter outreach coordinator may, with the approval of the administrator of the high school or his or her designee, coordinate election related activities on his or her high school campus, including voter registration drives or other election related pupil outreach activities.
K. Principals or their designees will report to the Superintendent or designee the number of students who register to vote on campus and will provide input regarding best practices and any areas of concern or improvement which might be incorporated into the Administrative Regulations for this policy in the future.
L. Student leadership/ASB groups will be encouraged to participate in an active manner in the student voter registration process on campus.
M. School principals shall follow up with their staffs to remind Grade 12 students during senior class assemblies and graduation preparation of the importance to vote and the means to register to vote.
N. The Superintendent or designee shall place a link to the Secretary of State's online voter registration application on the district website and each school's website (hppt://registertovote.ca.gov).

Instruction

The Governing Board recognizes the positive benefits of physical activity for student health and academic achievement.

The Board desires to provide an activity-focused physical education program that supports the district's coordinated student wellness program, builds interest and proficiency in movement skills, and encourages students' lifelong fitness through physical activity. Besides promoting high levels of personal achievement and a positive self-image, physical education activities should teach students how to cooperate in the achievement of common goals.

(cf. 5030 – Student Wellness) (cf. 5121 – Grades/Evaluation of Student Achievement) (cf. 6142.8 – Comprehensive Health Education) (cf. 6145.2 – Athletic Competition) (cf. 6146.1 – High School Graduation Requirements)

The Board shall approve the components of the physical education program. The district's program shall be aligned with state model content standards and curriculum frameworks for physical education and shall include a variety of kinesthetic activities, including team and individual sports, as well as aesthetic movement forms, such as dance.

An appropriate alternative activity or exemption from the physical education class shall beprovided for a student with disabilities in accordance with his/her individualized educationprogram or 504 accommodation plan.

The district's physical education program shall be provided by appropriately credentialed teachers. The physical education staff shall appropriately limit the amount or type of physical exercise required of students during air pollution episodes, hot weather, or other inclement conditions.

Continuing professional development shall be offered to physical education teachers and to-

classroom teachers serving as instructors of physical education in order to enhance the quality of instruction and the variety of activities offered.

The Superintendent or designee shall annually administer the physical fitness test designated by the State Board of Education to students in grades 5, 7, and 9. (Education Code 60800)

The Superintendent or designee shall annually report to the Board the results of the physical-fitness testing for each school and applicable grade level. He/she shall also report to the Board-regarding the number of instructional minutes offered in physical education for each grade level, the number of two-year and permanent exemptions granted pursuant to Education Code 51241 as described below, and any other data agreed upon by the Board and the Superintendent or designee to evaluate the effectiveness of the district's program in meeting goals for physical-activity.

The Superintendent or designee shall report the aggregate results of the physical performance testing in the annual school accountability report card required by Education Code 33126 and 35256. (Education Code 60800)

**Temporary Exemptions** 

The Superintendent or designee may grant a temporary exemption from physical education under either of the following conditions: (Education Code 51241)

- The student is enrolled for one half time or less.
- 2. The student is ill or injured and a modified program to meet his/her needs cannot be-provided.

Two Year Exemptions

With a student's consent, the Superintendent or designee may exempt the student from any two years of physical education courses during grades 10-12 provided that the student has satisfactorily met any five of the six standards of the state's physical fitness test in grade 9. (Education Code 51241)

Upon request by students and/or their parents/guardians, the Superintendent or designee alsomay administer the physical fitness test to students in grades 10-12 who need to pass the test inorder to qualify for a two-year exemption from physical education courses. To be eligible toreceive the two-year exemption, the student's performance on the state's physical fitness test shall have been classified in the "healthy fitness zone" for five of the six fitness areas tested.

The physical fitness test shall be administered at the end of each semester to students in grades 11—12 who failed to pass the test in grades 9 or 10. If the student has satisfactorily met any five of the six standards of the state's physical fitness tests and has earned 20 credits in physical education, the student will have met the district's physical education requirement.

### Permanent Exemptions

The Superintendent or designee may grant permanent exemptions from physical education to a student who is either: Â (Education Code 51241)

- Age 16 years or older and has been in grade 10 for one or more academic years
- Enrolled as a postgraduate student
- 3. Enrolled in a juvenile home, ranch, camp or forestry camp school with recreation and exercise scheduled

# Other Exemptions

The Superintendent or designee may grant an exemption from physical education under the following special circumstances:

- 1. The student in grades 10-12 is excused for up to 24 clock hours in order to participate in automobile driver training. (Education Code 51222)
- 2. The student in grades 10-12 attends a regional occupational center or program and attendance in physical education courses results in hardship because of the travel time involved. (Education Code 52316)
- 3. The student is in high school and is engaged in a regular school-sponsored interscholastic athletic program carried on wholly or partially after regular school hours. (Education Code-51242)

The Governing Board recognizes the positive benefits of physical activity on student health and academic achievement. The district shall provide all students the opportunity to be physically active on a regular basis through high-quality physical education instruction and may provide additional opportunities for physical activity throughout the school day. The district's physical education and activity programs shall support the district's coordinated student wellness program and encourage students' lifelong fitness.

The district's physical education program shall provide a developmentally appropriate sequence of instruction aligned with the state's model content standards and curriculum framework.

The Board shall approve the courses in grades 9-12 for which physical education credit may be granted.

Physical education instruction shall be delivered by appropriately credentialed teachers who may be assisted by instructional aides, paraprofessionals, and/or volunteers.

The district shall provide physical education teachers with continuing professional development, including classroom management and instructional strategies designed to keep students engaged and active and to enhance the quality of physical education instruction and assessment.

**Physical Fitness Testing** 

The Superintendent or designee shall annually administer the physical fitness test designated by the State Board of Education (FITNESSGRAM) to students in grades 5, 7, and 9. (Education Code 60800; 5 CCR 1041)

**Temporary Exemptions** 

The Superintendent or designee may grant a student a temporary exemption from physical education under either of the following conditions: (Education Code 51241)

- 1. The student is ill or injured and a modified program to meet his/her needs cannot be provided.
- 2. The student is enrolled for one-half time or less.

**Two-Year Exemptions** 

With the student's consent, the Superintendent or designee may exempt a student from physical education courses for any two years during grades 10-12 provided that the student has satisfactorily met at least five of the six standards of the FITNESSGRAM in grade 9. (Education Code 51241)

Upon request by students and/or their parents/guardians, the Superintendent or designee may administer the FITNESSGRAM to students in grades 10-12 who need to pass the test in order to qualify for a two-year exemption from physical education courses.

Students in grades 10-12 who have been granted a two-year exemption shall be offered a variety of elective physical education courses of not less than 400 minutes each 10 school days. (Education Code 51222)

Such students shall not be permitted to attend fewer total hours of courses and classes than they would have attended if enrolled in a physical education course. (Education Code 51241)

**Permanent Exemptions** 

The Superintendent or designee may grant a student a permanent exemption from physical education under any of the following conditions: (Education Code 51241)

- 1. The student is age 16 years or older and has been enrolled in grade 10 for one or more academic years. However, such a student shall not be permitted to attend fewer total hours of courses and classes than he/she would have attended if enrolled in a physical education course.
- 2. The student is enrolled as a postgraduate student.
- 3. The student is enrolled in a juvenile home, ranch, camp, or forestry camp school with scheduled recreation and exercise.

# **Other Exemptions**

The Superintendent or designee may grant a student an exemption from physical education under the following special circumstances:

- 1. When the student is in any of grades 10-12 and is excused for up to 24 clock hours in order to participate in automobile driver training. However, any such student shall attend a minimum of 7,000 minutes of physical education instruction during the school year. (Education Code 51222)
- 2. When the student is in any of grades 10-12, attends a regional occupational center or program, and, because of the travel time involved, would experience hardship to attend physical education courses. Any such student shall have a minimum school day of 180 minutes. (Education Code 52316)

3. When the student is in high school and is engaged in a regular school-sponsored interscholastic athletic program carried on wholly or partially after regular school hours. (Education Code 51242)

#### **Program Evaluation**

The Superintendent or designee shall annually report to the Board each school's FITNESSGRAM results for each applicable grade level. He/she shall also report to the Board regarding the number of instructional minutes offered in physical education for each grade level, the number of two-year and permanent exemptions granted pursuant to Education Code 51241, and any other data agreed upon by the Board and the Superintendent or designee to evaluate program quality and the effectiveness of the district's program in meeting goals for physical activity.

# **Administrative Regulation**

**Physical Education** 

AR 6142.7 Instruction

Instruction in physical education shall be provided for a total period of time of not less than 200-minutes each 10 school days for students in grades 1 through 6 and not less than 400 minutes each 10 school days for students in grades 7 through 12. Â (Education Code 51210, 51222)

Students in grades 10-12 who have been granted a two-year exemption pursuant to Education Code 51241(b) shall be offered a variety of elective physical education courses of not less than 400 minutes each 10 school days. (Education Code 51222)

Students in grades 10-12 who have been granted a two year or permanent exemption from physical education pursuant to Education Code 51241(b)(1) or (c) shall not be permitted to attend fewer total hours of courses and classes than they would have attended if enrolled in a physical education course. (Education Code 51241)

Students in a regional occupational program or center who are exempted from physical education pursuant to Education Code 52316 shall have a minimum school day of 180 minutes. (Education Code 52316)

During the month of February, March, April or May, students in grades 5, 7 and 9 shall undergothe physical performance testing designated by the State Board of Education. (Education Code-60800)

(cf. 6162.5 - Student Assessment)

The Superintendent or designee may provide a make up date for students who are unable to take the test based on absence or temporary physical restriction or limitations, such as students recovering from illness or injury. (5 CCR 1043)

On or before November 1 of each school year, the Superintendent may designate an employee to serve as the district's physical fitness test coordinator and so notify the test contractor. The test coordinator shall serve as the liaison between the district and California Department of Education for all matters related to the physical fitness test. His/her duties shall be those specified in 5 CCR 1043.4, including, but not limited to, overseeing the administration of the test and the collection and return of all test data to the test contractor. (5 CCR 1043.4)

Students shall be provided with their individual results after completing the physical performance testing. The test results may be provided in writing or orally as the student completes the testing. (Education Code 60800; 5 CCR 1043.10)

Each student's scores on the physical performance test shall be included in his/her cumulative-record. (5 CCR 1044)

**Testing Variations** 

All students may be administered the state's physical fitness test with the following test-variations: (5 CCR-1047)

- 1. Extra time within a testing day
- 2. Test directions that are simplified or clarified

All students may have the following test variations if they are regularly used in the classroom: (5-CCR-1047)

- 1. Audio amplification equipment
- 2. Separate testing for individual students provided that they are directly supervised by the test-examiner
- 3. Manually Coded English or American Sign Language to present directions for test administration

Students with a physical disability and students who are physically unable to take all of the test shall undergo as much of the test as their physical condition will permit. (Education Code 60800; 5 CCR 1047)

Students with disabilities may be provided the following accommodations if specified in their individualized education program (IEP) or Section 504 plan: (5 CCR 1047)

- 1. Administration of the test at the most beneficial time of day to the student afterconsultation with the test contractor
- Administration of the test by a test examiner to the student at home or in the hospital
- 3. Any other accommodation specified in the student's IEP or Section 504 plan for the physical fitness test

Identified English learners may be allowed the following additional test variations if regularly used in the classroom: (5 CCR 1048)

- 1. Separate testing with other English learners, provided that they are directly supervised by the test examiner
- Test directions translated into their primary language, and the opportunity to ask clarifying questions about the test directions in their primary language

## **Definitions**

Physical education is a sequential educational program that teaches students to understand and participate in regular physical activity for developing and maintaining physical fitness throughout their lifetime, understand and improve their motor skills, enjoy using their skills and knowledge to establish a healthy lifestyle, and understand how their bodies work.

Physical activity is bodily movement that is produced by the contraction of skeletal muscle and that substantially increases energy expenditure, including exercise, sport, dance, and other movement forms.

Moderate physical activity is any activity which generally requires sustained, rhythmic movements and refers to a level of effort a healthy individual might expend while, for example, walking briskly, dancing, swimming, or bicycling on level terrain. A person should feel some exertion but should be able to carry on a conversation comfortably during the activity.

Vigorous physical activity is any activity which generally requires sustained, rhythmic movements and refers to a level of effort a healthy individual might expend while, for example, jogging, participating in high-impact aerobic dancing, swimming continuous laps, or bicycling uphill. Vigorous physical activity may be intense enough to result in a significant increase in heart and respiration rate.

## **Instructional Time**

Instruction in physical education shall be provided for at least the following minimum period of time: (Education Code 51210, 51222, 51223)

- 1. For students in grades 1-6, 200 minutes each 10 school days, exclusive of recesses and the lunch period
- 2. For students in grades 7-8 attending an elementary school, 200 minutes each 10

school days, exclusive of recesses and the lunch period

- 3. For students in grades 7-8 attending a middle school or junior high school, 400 minutes each 10 school days
- 4. For students in grades 9-12, 400 minutes each 10 school days

If the instructional minute requirement cannot be met during any 10-day period due to inclement weather, a school assembly, field trip, student assessment, or other circumstance, the school shall make up those minutes on another day in order to satisfy the instructional minute requirement.

The Superintendent or designee shall determine a method to document compliance with the required number of instructional minutes. Such documentation may include, but not be limited to, a master schedule, teacher roster, or log for staff or students to record the number of physical education minutes completed.

Any complaint alleging noncompliance with the instructional minute requirement for elementary schools may be filed in accordance with the district's procedures in AR 1312.3 - Uniform Complaint Procedures. A complainant not satisfied with the district's decision may appeal the decision to the California Department of Education (CDE). If the district or the CDE finds merit in a complaint, the district shall provide a remedy to all affected students and parents/guardians. (Education Code 51210, 51223; 5 CCR 4600-4687)

**Monitoring Moderate to Vigorous Physical Activity** 

To monitor whether students are engaged in moderate to vigorous physical activity for at least 50 percent of physical education class or session time, the Superintendent or designee may:

- 1. Develop methods to estimate the amount of time students spend in moderate to vigorous physical activity or the number of students who are inactive during physical education classes
- 2. Provide physical education teachers with staff development, self-monitoring tools, stopwatches, and/or heart rate monitors to assist them in planning and assessing the level of activity in their classes

(cf. 4115 - Evaluation/Supervision)

**Physical Fitness Testing** 

During the annual assessment window between the months of February through May, students in grades 5, 7, and 9 shall be administered the physical fitness test designated by

the State Board of Education (FITNESSGRAM). (Education Code 60800; 5 CCR 1041)

(cf. 6162.5 - Student Assessment)

The Superintendent or designee may provide a make-up date for students who are unable to take the test based on absence or temporary physical restriction or limitations, such as students recovering from illness or injury. (5 CCR 1043)

On or before November 1 of each school year, the Superintendent may designate an employee to serve as the district's physical fitness test coordinator and so notify the test contractor. The test coordinator shall serve as the liaison between the district and California Department of Education for all matters related to the physical fitness test. His/her duties shall be those specified in 5 CCR 1043.4, including, but not limited to, overseeing the administration of the test and the collection and return of all test data to the test contractor. (5 CCR 1043.4)

Students shall be provided with their individual results after completing the FITNESSGRAM. The test results may be provided in writing or orally as the student completes the testing and shall be included in his/her cumulative record. (Education Code 60800; 5 CCR 1043.10, 1044)

(cf. 5125 - Student Records)

Each student's test results shall also be provided to his/her parents/guardians.

The Superintendent or designee shall report the aggregate results of the FITNESSGRAM in the annual school accountability report card required by Education Code 33126 and 35256. (Education Code 60800)

(cf. 0510 - School Accountability Report Card)

**Testing Variations** 

All students may be administered the FITNESSGRAM with the following test variations: (5 CCR 1047)

- 1. Extra time within a testing day
- 2. Test directions that are simplified or clarified

All students may have the following test variations if they are regularly used in the classroom: (5 CCR 1047)

- 1. Audio amplification equipment
- 2. Separate testing for individual students provided that they are directly supervised

by the test examiner

3. Manually Coded English or American Sign Language to present directions for test administration

Students with a physical disability and students who are physically unable to take all of the test shall undergo as much of the test as their physical condition will permit. (Education Code 60800; 5 CCR 1047)

Students with disabilities may be provided the following accommodations if specified in their individualized education program (IEP) or Section 504 plan: (5 CCR 1047)

- 1. Administration of the test at the most beneficial time of day to the student after consultation with the test contractor
- 2. Administration of the test by a test examiner to the student at home or in the hospital
- 3. Any other accommodation specified in the student's IEP or Section 504 plan for the physical fitness test

Identified English learners may be allowed the following additional test variations if regularly used in the classroom: (5 CCR 1048)

# 5. Ratification of Administration's Approval of Assignments Through Various Education Codes Current statutes and regulations recognize that there may be situations of a temporary mature in which a teacher with the appropriate credential is not available to the School District or the assignment is part-time and not conducive for recruitment. Senate Bill 435 has made it possible to assign staff with their permission to these areas in several ways:

**Education Code 44256(b)** states that the holder of a self-contained type credential may be assigned, with his or her consent, teach any subject in <u>departmentalized</u> classes, below grade 9, in which the teacher has 12 semester hours of coursework in the subject area.

**Education Code Section 44861** allows a credentialed teacher to substitute as a principal for up to five months, if the teacher's credential is for the same grade as the school to be administered. The employing agency determines the definition of 'emergency' for this section. This option is limited to a substitute principal only.

**Education Code 44263** states that the holder may be assigned, with his or her consent, to teach any single subject class in which the teacher has 18 semester hours of coursework or a self-contained classroom with 60 semester hours distributed among four of the following subjects: language studies, literature, mathematics, science, social science, history, humanities, the arts, physical education, and human development.
