## The Merit System

The merit system, first institutionalized in the United States with the passage of the Civil Service Act of 1883 and later in California's school system in 1936, is, simply stated, a fair and equitable personnel management system for classified employees. Incorporating a system of rules and procedures, similar to civil service, the Personnel Commission is the mainstay of the merit system. It is an independent body composed of the three persons appointed for three-year staggered terms. The fundamental purpose of the merit system and the Personnel Commission is to ensure that classified employees are selected, promoted and retained without favoritism or prejudice, and solely on the basis of merit and fitness. The California Education Code empowers and sets forth the responsibilities of the Personnel Commission. In addition to its responsibility for setting policy with regard to the Human Resources management function for all classified employees (represented, Management and Confidential), the Personnel Commission has the responsibility for serving as the body that hears appeals of disciplinary actions taken against permanent Classified employees by the Board of Education.

### Personnel Commission

The Personnel Commission is an independent body composed of three persons appointed for three-year, staggered terms, with the term of one member expiring each year. The Commission is composed of a member appointed by the District's Board of Education, and a member recommended by the classified employees of the district (VESPA) and approved by the Board of Education. Those two appointees, in turn, appoint the third member. At its first regularly scheduled meeting in December, the Commission elects one of its members to serve as Chairperson and another of its members to serve as Vice Chairperson for a one-year term.

The Personnel Commission regularly meets on the third Wednesday of each month at 4:30 p.m., unless otherwise posted. Meetings are held at the Education Service Center, located at 255 W. Stanley Avenue in Ventura. Classified employees, as well as all other district employees and the public, are encouraged to attend.

We are grateful for the time Commissioners invest volunteering in their role to serve the classified service, and the valuable partnership they offer in supporting a successful future for the students of the Ventura Unified School District.

#### Commissioners



Anne Campbell was appointed as the Board's Appointee to the Commission in December 2020. Ms. Campbell retired from the Ventura Unified School District in 2020 with over 24 years of service to the students of our District. She began her career as a classified employee, and then moved into a certificated role as a Teacher. In addition, she has private industry experience, and served many years as a volunteer in many capacities. Ms. Campbell's unique combination of experiences provides a well-rounded foundation in the role she serves as a Commissioner.



John Walker was appointed as the Joint Appointee in June 2020 to finish out Mr. Lacey's term through December 1, 2021. Mr. Walker previously served as a VUSD Board of Education Member for 29 years, 1989 - 2018. In addition, after retiring from his 34 year career with Verizon, Mr. Walker went on to serve as the Classified Human Resources Director for Ojai Unified School District, and in post-retirement continues to assist their Personnel Commission. VUSD is grateful for the experience Mr. Walker brings to his role as a Personnel Commissioner, as well as the history and connection he has with the District.



Cathi Stallings was appointed to the Commission as the classified employees' appointee in December 2019. Ms. Stallings retired from VUSD after 33 years of service. Ms. Stallings served in various classified positions during her career with VUSD, and most recently worked as an Administrative Specialist in the Curriculum & Instruction Department. In addition, Ms. Stallings was a collaborative leader for the Ventura Education Support Professionals Association, and served as Negotiations Chair for many years. Ms. Stallings' experience as a union leader allows her to identify the needs of classified employees and champion providing exceptional personnel services to the employees and community of VUSD.

### Meet the Staff

Andrea Crouch, Director of Classified Human Resources: Administers the classified employee human resources function in conformity with merit system laws and rules of the Personnel Commission, and assures compliance with District policies and procedures, and applicable federal, state and local laws; plans, organizes and directs the human resources program for classified employees that enhance cultural and ethnic diversity, including recruitment, examination, classification, salary and employee relations; supervises the operations of the Classified Human Resources Department; serves as advisor to the negotiations team; and acts as secretary to the Personnel Commission.

**Belen Gonzalez, Human Resources Supervisor:** Serves as a strategic partner in providing consultation to personnel, administrators, applicants and others regarding classified human resources operations and activities; responding to inquiries and providing technical information and guidance concerning recruitment and selection, laws, rules, regulations, processes, policies and procedures.

**Vacant, Human Resources Analyst (Confidential):** Performs technical human resources work related to position classification; compensation; recruitment and examinations. Assists department and Personnel Commission by coordinating and serving as the primary resource for the support activities of the department. Also participates as a resource representative in the collective bargaining process, and takes and transcribes minutes of negotiations sessions.

**Jackie Lopez, Human Resources Specialist:** Performs a variety of specialized human resources duties in support of recruitment and selection, and employment screening and processing. Works closely with school site personnel to coordinate sub assignments, and serves as a lead managing the absence management tracking system (Frontline). Expert HR partner in acquiring talent and placing in appropriate assignments where strengths best serve our students, programs, sites and support services.

**Reina Murillo, Human Resources Specialist:** Performs a variety of specialized human resources duties in support of recruitment and selection, and database and systems development. Serves as a technical resource to employees, applicants and others regarding personnel functions. Expert HR partner in evaluating established systems and structures, and developing and implementing strategies and methods to improve processes.

**Rita Montejano, Human Resources Technician:** Performs technical human resources work to support classified recruitment, examination, and selection, and provides procedural guidance to staff and applicants. Fosters relationships and works closely with other merit system district personnel within the County to provide professional experts to serve on interview panels as part of the examination process.

**Maria Lopez, District Receptionist:** Serves as the District receptionist, answering and directing telephone calls to appropriate personnel; greets and assists visitors, determines nature of business and directs to appropriate destination; performs a variety of clerical duties in support of District operations.
